## President's Message

Some comments about our latest distribution of calendar proceeds to small projects.

Overall I was pleased with the way the process worked this time, and it will be easy to correct some of the glitches. I particularly appreciate the efforts of Buck, Meredith, Sharon, and John (Elder) who worked on the Project Review Committee with me. It was relatively easy to recommend funding for each project, due largely to Barbara's well-designed Project Application Form. Those of us on this committee appreciate the vote of confidence we received from the general membership when our recommendations as printed in the newsletter were approved. I was also happy not to have to sit at the general meeting with my calculator in hand and keep a running tally of how people's suggestions for funding would affect the overall amount requested.

One interesting thing that happened was that many of the people who requested funding did not participate in the project review process. I was somewhat surprised by this lack of input. Apparently people were reasonably satisfied by the manner in which their requests were handled because I have not received any complaints about the process yet.

The major problem we faced in this process was providing information about the project requests to our members for their consideration. As I was reminded, the application was designed so that it could be easily reduced during copying to allow the vital information about 8 projects to be reproduced on one double-sided page. Because we received 23 applications, the committee agreed with my suggestion to prepare a single page (double-sided) summary of the information we received on the projects rather than take up three full pages of the newsletter. (Besides, there is no guarantee that the newsletter editor will include all of that in the newsletter. He decides what goes in the newsletter.) The unfortunate result, though, was that the membership was asked to approve \$6,025 in funding without having full information about the projects being funded.

One way to avoid this problem in the future is to send our members a separate mailing containing the application information and committee recommendations. This approach would also allow our members to see how other people have filled out the application. However, such a mailing would cost us about \$100. Since we have a committee in place to review the project applications, I'm not convinced that we really need a separate mailing. Please let me know your feelings on this matter.

I had another problem. I felt it was time to distinguish the small projects that we were funding from special projects that require more funds. We have not developed procedures for dealing with special project requests, and I felt that some of the requested donations (\$1,000) were large enough to be considered as special projects by our standards. After extensive discussion I conceded that I was a minority of one and that these requests did not constitute special projects. We'll know them when they come up and will deal with them at that time. I would like to revise the application by adding the following statement: "Our typical donations for small projects are from \$150 to \$600". Again I need feedback on this issue.

Final problem - the members of the Project Review Committee assumed that only one meeting was needed. However, the committee is also responsible for record keeping. I guess I can handle the details of getting the checks dispersed (and it makes sense for the Prez to keep the requests with our other records), but some help would be appreciated. Thanks!

No further business needed to be conducted so the meeting was adjourned at 8:55 pm.

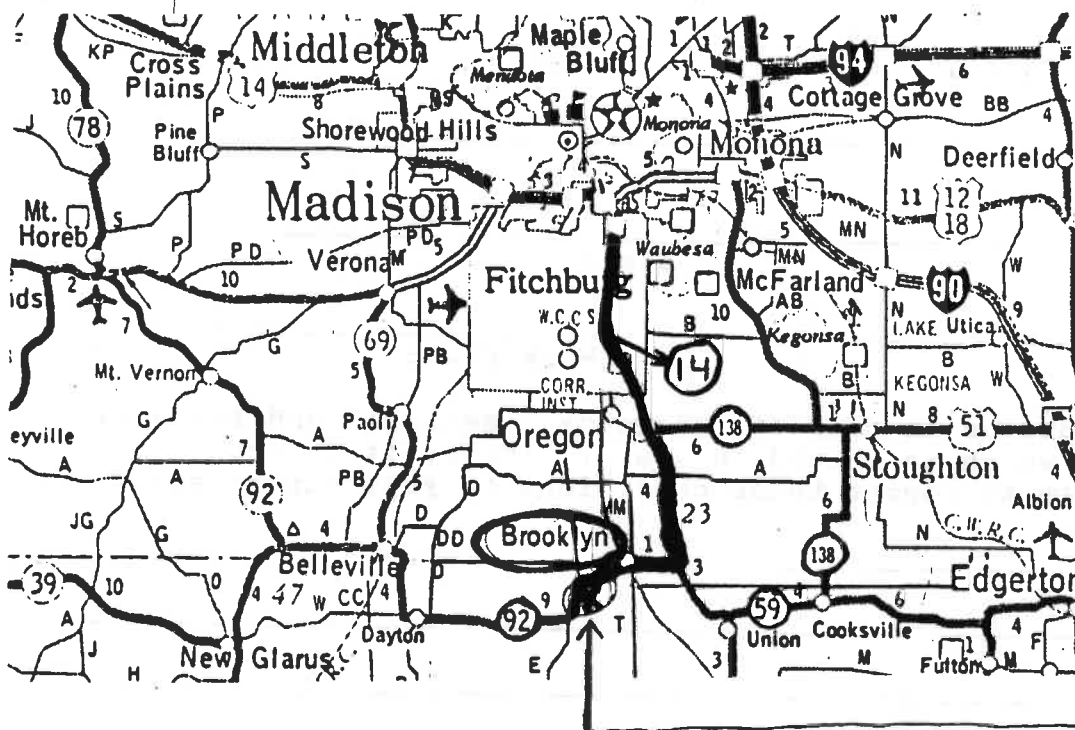

# THE CANOE TRIP

The third annual RPCV canoe trip is scheduled for August 7 & 8. The Wisconsin River is our highway from Muscoda to Woodman. We will camp on an island/sand bar somewhere between Blue River and Boscobel. Like last year, the trip will cover about 20 miles in two days, which is an easy pace, neither an effortless or strenuous paddle. Children of all ages are welcomed. The lower Wisconsin is a beautifully calm river, but danger exists for the young and unwary.

## What to bring

Here is a basic list of necessary items (other than swimming gear). I have a more detailed list for those who want one.

Watercraft of your choice: If you want to rent a canoe, let me know so I can reserve one for you from a place in Muscoda. The cost is about \$20 per day, including the shuttle. If you are a Hooper you can get one much cheaper from the Outing Club at UW. Please don't ask if you can bring your jetski.

Lif jackets: Everyone must have one. If you rent a canoe you will be given one for each passenger. Children who cannot swim must wear one at all times.

Mosquito repellent and a tent with netting: It may or may not rain, but come twilight there will definitely be hordes of mosquitos. This is the worst part of the trip, but they go to bed after a few hours.

Food: A island potluck is planned on Saturday evening. If you can round up a coleman stove please let me know. Bring your drinking water in gallon milk jugs, beer & ice in coolers. Glass is verboten on the Lower Wisconsin River.

Deadline: Please let me know if you plan come no later than July 30th (I'll be out of town till August 5th). I will need a deposit if you want to rent a canoe. Assistance is needed with the shuttle, so let me know if you plan to drive and can carry some canoes on top of your car. My phone is 835-5976.

## Minutes of International Calendar Steering Committee (ICSC) Meeting

In attendance: Don Sauer, Walt Zeitner, Kevin Nies, Buck Trawicky, Barbara Chatterjee, Henry Nehls-Lowe

Kevin was appointed the designated minutes taker for this meeting.

It was determined that the August meeting of the ICSC would be held on 15 August 93.

### MARKETING & DISTRIBUTION & PRODUCTION

Walt & Don stated that the Connecticut group is organizing a North East RPCV Regional Conference and that our calendar is being "promoted" in the registration materials. Don stated that he would be meeting Shelley Cruz, who is the spokesperson for the CT group, at the National Conference. She will get calendars and postcards from Don at that time.

Don stated that he had shipped 500 calendars to the Cincinnati group this past week which will be used in conjunction with Rudy Sovinee at the Parent - Teachers Association conference to be held 27 - 29 June in Cincinnati.

Don indicated that we've already received orders for 45 1994 Calendars. These early orders no doubt generated by our ad in the "World View." For the Fall issue of this magazine, we are tentatively penciled in for an ad on the entire back page. It was felt that this would give the calendar good exposure and it was decided to proceed with developing an ad. Buck and Henry expressed their interest in getting involved in this with the possible assistance of Lori Merriam.

Henry stated that he was contacted by one of the calendar photographers about the World University Games that will be held in Buffalo, NY. It was felt that this would be a good venue for calendar promotion. Don and Kevin will attempt to make contact with an RPCV group in that area in order to determine the possibility of doing this.

Buck will get in contact with the editor of the "Whole Earth Review" (a publication associated with the "Whole Earth Catalog") with the intent of getting our calendar reviewed. The end result, it is hoped, would be to generate calendar sales.

National Conference will be coming up soon and it will be the 1st big event for the 1994 International Calendar unveiling. We hope to sell all the calendars that are shipped out to the Conference. We may also be selling packs of postcards. It was decided that we would have packages of 12 postcards shrink-wrapped. Each pack would contain 4 of each type of postcard. It was determined that we would probably sell each pack for \$3. Don will look into the possibility of having a sheltered workshop do the shrink-wrapping and labeling. Don and Henry will work on creating a label. We plan on packaging 5000 of each type of postcard in this way. A number of these packs of postcards will be marketed at the National Conference. We will also be handing out individual postcards at National Conference. These postcards will have calendar order forms printed on them. It is hoped that these will also generate calendar sales.

Barbara will take care of getting calendar brochures produced. These brochures would be similar to the ones we produced last year. The brochures explain the concepts behind the International Calendar and what happens to generated monies.

### REIMBURSEMENT

This topic was broken into two sections: Recompense for Photographers and Recompense for volunteers working on calendar production, marketing and distribution.

In discussions concerning recompense for calendar photographers, it seemed to be decided that we would stick with giving 25 calendars per photo used to each photographer. If the photographer wanted more calendars, they could be purchased at discount rates.

In discussions concerning recompense of volunteers working on calendar production, marketing and distribution, it was felt that emphasis needs to be placed on the word "volunteer". In the end discussions concerning reimbursement were tabled as to the greyness of this topic.

Thanks for your help on the Peace Corps Budget. Since I didn't catch you in when I called to tell you how it went, I thought I'd send a fax. Maybe you could do me the favor of sharing this info with others in your group.

The good news is that Peace Corps was one of only two entities for which a budget cut (below the President's recommendation) was *not* recommended by Rep. Obey's subcommittee. And relatively speaking, that is very good news. The other program which was not cut was refugee assistance.

Your phone calls very likely helped save Peace Corps from deeper cuts. It is this kind of grass roots lobbying that helps offset those better-financed lobbies which push for more military assistance.

Peace Corps was one of only five programs to be recommended for an increase over the 1993 appropriation. The others were population programs, assistance to the newly independent states, refugee assistance, and peace keeping. Rep. Obey's subcommittee recommended for Peace Corps the \$219.7 million requested by the Administration. In order to support 8,000 volunteers in the field, 2,000 below the Congressionally mandated strength, Peace Corps would need a budget of \$254 million.

Other programs sustained at least a two per cent cut and several were much deeper. A cut was recommended in AID development assistance from the \$1.03 billion authorized for FY 1993 to \$816 million for FY 1994. That is not good news, because that is the account from which support for sustainable development comes.

\$2.37 billion was recommended for the Economic Support Fund, a cut from \$2.7 billion in FY 93. These are the funds which can be used for special economic or security purposes, regardless of human need. Of these, 85 per cent are earmarked for Egypt and Israel.

The recommendation from Rep. Obey's Subcommittee now goes to the House Appropriations Committee where it will be considered along with those from the other 12 subcommittees. Few changes are expected to be made by the full committee. However, a larger appropriation may come out of the parallel process in the Senate.

In light of the wide-spread budget cutting fever, the perceived unpopularity of foreign assistance programs, and the strength of the Israel/Egypt lobby, Rep. Obey's Subcommittee did well by the Peace Corps. You may want to think about sending him a thank you letter. Thanking him for doing what he could does not imply that you are totally satisfied, but rather that you recognize the political reality within which he works and that you hope to see further changes in the future.
